Even if you feel well, stay at home as much as possible. In public, wear a mask and keep at least 6 feet distance from others. Avoid unnecessary appointments.


Wash Your Hands. Cover Your Cough

The Life and Times of Emerald Snow Birds in Florida.

Hello boys and girls and children of all ages.

Greetings from the sunshine state. Compared to last month, the weather is delightful at present. But other than that, not much has changed. Remnants of the coronavirus pandemic and the associated restrictions are still with us.

I seem to have adopted a Muscovy duck and her twelve eggs. Claire accidentally found the nest next to the front door after Mrs. Duck squawked and scared her. I got friendly with our new find by giving her some water and scraps of food. It pays to be nice. This bird is as big as a goose and I don't understand why they are called ducks. We have a plentiful supply down in Boynton Beach but it is illegal or discouraged to feed them. As a result, I don't befriend them. Our duck is hatching twelve eggs but there is no Mr. Duck around.

The hatching period for Muscovy ducks is five weeks and since we were not here to know when the project started; I am not sure when we can expect babies. Since I write this report in bits and pieces throughout the month, I should see little ones by the time this is submitted. Since she is the only duck on the lake here in Ormond it raises some questions as to where she originated. I have added her care to my morning routine.

I first check on her when I get up, then I replenish her water. On weekdays she gets oat meal and on weekends it is pancakes. Every day around 4PM she leaves the nest and goes for a walk. I figure she goes to the "Duck Bar" for a beer. If I don't see ducklings by the middle of October and with no Mr. Duck around, I will conclude that Mrs. Duck got fooled and she will wind up with gluggers. Stay tuned.

The Fall weather has arrived in South Florida and I must say, it is most welcome. The coronavirus is still with us but in a reduced state. They have eased up on some of the restrictions. Since there are no church services, the chances of meeting or seeing some Emeralds is zero comma none at this time. The snowbirds who ventured up north should be returning shortly. I will keep my eyes and ears open. My garden has taken a beating from the heavy downpours that are common here in South Florida during the Fall months. I guess there is always next year.

Our Muscovy duck had done her job. On the evening of October 3rd, I noticed the first baby. But next morning there were seven more. There was eight in total, one of the ducklings was completely yellow. One egg got broken and there were three gluggers. That accounts for all the eggs. I was thinking that with eight extra mouths to feed that I would be eligible for food stamps.

When I visited my duck family on October 5th, I was both surprised and saddened. My ducklings were gone as well as the three gluggers. Some animal must have discovered the nest during the night and devoured its contents. End of story, sad but true.

That is all for now. Keep them cards and letters coming and we will chat again next month. Maybe an Emerald will show up. Otherwise, I will have to pull something from the sky that is both educational and entertaining.

The Society of Irish American Lawyers Scholarship

Information

The Society of Irish American Lawyers offers a \$1,000.00 scholarship to a graduating senior of Irish-American heritage from an accredited high school. Each student will be evaluated based upon the submitted scholarship essay, evidence of leadership and service to school and community, and the letter of recommendation. The applicant's demonstrated academic ability, as well as any factors relating to the applicant's character, may be considered by the scholarship selection committee.

In order to be considered, an applicant must:

- Have applied or be in the process of applying to a recognized and accredited post high school educational institution;
- Graduate from high school in 2021 or have graduated in 2020 and deferred admission to a post high school educational institution for a year;
- Be of Irish descent;
- Reside in the Ninth Judicial District (Westchester, Dutchess, Putnam, Orange and Rockland); and
- File a completed application, including the essay, transcript, and letter of recommendation, by midnight on December 1, 2020, via email to SocialScholarship2021@gmail.com.

The application must include:

- An essay of at least 250 words (typed and double-spaced) but no more than 350 words addressing the topic: "How your Irish heritage has influenced your life and goals";
- One letter of recommendation (this can be from a teacher, coach or employer);
- A high school transcript (does not need to be certified). The transcript must include grades for the 9th through 11th year, a three-year average, and class rank (if available);
- A record of any awards or extracurricular activities, including employment;
- · A record of any service to the community; and
- A completed Certification and Acknowledgement form.

After review of all written applications, the Scholarship Committee will select the five top candidates who will then be interviewed by the committee before the final winner is decided.

Payment of the scholarship award will be made upon verification in writing of the recipient's accepted attendance to an accredited post high school educational institution.
