Each year SOCIAL hosts a "Halfway to St. Patrick's Day event" in September, providing a valuable networking opportunity for lawyers. Annually, there is a March Gala, where SOCIAL celebrates St. Patrick's Day together; honors a member of the bar; awards a scholarship and enjoys Irish music.
